
With reference to the subject mentioned above I am directed to inform you that the Hon'ble Vice-Chancellor of West Bengal State University is pleased to approve the affiliation of new B.Ed College in the name of Adharsha College of Education (B.Ed.) Vill+P.O.-Kadambagachi, P.S.-Barasat, North Parganas, West Bengal, Pin-700124 from 2013-14 academic session after getting the concurrence of University Council in its meeting held on 27/04/2013, subject to fulfillment of the following conditions:

01. The approval of affiliation for the said college will be temporary w.e.f. 2013-14 academic session.
02. An amount of Rs. 41,000.00/- has to be paid by the college authority to the University as an inspection and affiliation fee by Demand Draft in favour of West Bengal State University, payable at Barasat or Kolkata.
03. The aforesaid College will be allowed to offer following subjects from the academic session 2013-2014. Bengali, English, History, Geography, Life Science, Physical Science, Mathematics, Sanskrit, Arabic, Education, Music/Fine Arts, Physical Education, Work Education, Philosophy, Eco-Civics.
04. The intake capacity will be 100 students per batch per year as per the guidelines of NCTE.
05. The syllabus of the B.Ed. Course will be followed as per University norms.
06. The College authority will have to follow the guidelines of the affiliating University. Govt. of W.B. and NCTE as and when required.
07. Required number of Teaching and Non-teaching employees including Librarian are to be appointed before starting the session.
08. Laboratories & Library are to be equipped in consultation with the experts.
09. The process of admission of students will be done following the guidelines of West Bengal State University.
10. The aforesaid College will be guided by the rules, regulations, statutes and ordinance etc. of West Bengal State University.
11. The University authority will nominate two Nominees in the Management Committee of the College following the guidelines of University.
